NARRATIVE  
 ON THE 1ST DAY OF MARCH 2008 THE DEFENDANT AT 200 BLK TO 400 BLK  
 PARK AVE, ORANGE PARK, FL, WITHIN CLAY COUNTY, VIOLATED THE LAW AND  
 DID THEN AND THERE: THIS OFFICER WAS CONTACTED BY A MOTORIST AND  
 ADVISED HE HAD FOLLOWED A GRAY PICKUP TRUCK FROM JACKSONVILLE AND HE  
 BELIEVED THAT THE DRIVER WAS D.U.I. THE MOTORIST ADVISED THAT THE  
 PICKUP HAD DROPPED OFF TWO BLACK MALES AT HWY 17 AND COLLINS RD AND  
 THE PICKUP CONTINUED SOUTHBOUND ON PARK AVE AND TURNED ONTO ELDRIDGE  
 AVE. THIS OFFICER OBSERVED TWO BLACK MALES WALKING SOUTH ON PARK AVE  
 AND THEY WERE OBSERVED GETTING INTO A PICKUP AT THE CHEVRON GAS  
 STATION. THE PICKUP PULLED ONTO PARK AVE AND CROSSED THREE LANES OF  
 TRAFFIC AND ENTERED INTO THE SOUTHBOUND LANE AND HEADED SOUTH ON PARK  
 AVE. THE VEHICLE CROSSED OVER INTO THE CENTER LANE AND ENTERED  
 ANOTHER TURN LANE. I ACTIVATED MY BLUE LIGHTS AND THE VEHICLE TURNED  
 INTO THE PARKING LOT OF THE ORANGE PARK KENNEL CLUB. UPON CONTACT ON  
 THE PASSENGER SIDE OF THE VEHICLE THE DRIVER OPENED THE GLOVE  
 COMPARTMENT AND I OBSERVED A HANDGUN IN THE GLOVE COMPARTMENT. I  
 ADVISED THE DRIVER SEVERAL TIMES TO REMOVE HIS HAND FROM THE GLOVE  
 COMPARTMENT AND HE CONTINUED TO DIG IN THE COMPARTMENT. UPON HAVING  
 THE OCCUPANTS EXIT THE VEHICLE THIS OFFICER OBSERVED A SMALL PLASTIC  
 BAG CONTAINING A WHITE POWDER SUBSTANCE LAYING ON THE PASSENGER SIDE  
 OF THE VEHICLE. THE DRIVER AND PASSENGER BOTH DENIED OWNERSHIP OF THE  
 WHITE POWDER. THE POWDER WAS FIELD TESTED AND FOUND TO BE POSITIVE FOR  
 COCAINE. THE DEFENDANT AND PASSENGER WERE BOTH ARRESTED FOR POSSESSION  
 OF A CONTROLLED SUBSTANCE AND BOOKED INTO THE CLAY COUNTY JAIL.

NARRATIVE

ON THE 1ST DAY OF MARCH 2008 AT 0227HRS THE DEFENDANT AT 455 PARK AVE, ORANGE PARK, FL, WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEN AND THERE: POSSESSION OF COCAINE. ON THE LISTED DATE AND TIME, I RECEIVED A BOLO FROM F.H.P. REGARDING A POSSIBLE IMPAIRED DRIVER IN A GRAY FORD F-150 SOUTHBOUND ON PARK AVE FROM THE COLLINS RD AREA OCCUPIED BY THREE BLACK MALES. CPL. KACZKOWSKI OBSERVED THE VEHICLE PARKED AT THE GAS PUMPS AT 206 PARK AVE. THE CLERK AT THE GAS STATION TOLD CPL. KACZKOWSKI THAT THE BLACK MALES ENTERED THE STORE THREE SEPARATE TIMES AND APPEARED SUSPICIOUS. CPL. KACZKOWSKI AND I STOPPED THE VEHICLE AT 455 PARK AVE. THE DRIVER OF THE TRUCK RESPONDED SLOWLY TO OUR SIGNALS TO STOP. UPON CONTACT WITH THE VEHICLE CPL. KACZKOWSKI ASKED THE DRIVER FOR HIS LICENSE AND REGISTRATION. WHEN THE DRIVER OPENED THE GLOVE BOX A BLACK/SILVER SEMI-AUTO PISTOL COULD BE SEEN INSIDE THE GLOVE BOX. WE THEN TOLD ALL PASSENGERS TO PUT THEIR HANDS UP REPEATEDLY, HOWEVER THE DRIVER CONTINUED TO REACH INSIDE THE GLOVE BOX. ALL OCCUPANTS WERE ORDERED OUT OF THE VEHICLE, PLACED INTO CUSTODY AND READ MIRANDA RIGHTS. WHEN THE DEFENDANT EXITED THE FRONT PASSENGER SEAT A SMALL PLASTIC BAG CONTAINING A WHITE POWDER WAS SEEN IN THE PASSENGER FLOORBOARD, WHICH FIELD TESTED FOR COCAINE. FURTHER SEARCH OF THE VEHICLE REVEALED A GREEN LEAFY SUBSTANCE IN THE CENTER CONSOLE CUP HOLDER AND A BLACK PISTOL MAGAZINE WITH BULLETS UNDER THE CONSOLE LID. POST MIRANDA, ALL THREE SUBJECTS DENIED ANY KNOWLEDGE OF THE COCAINE INSIDE THE TRUCK. THE DEFENDANT WAS ARRESTED AND TRANSPORTED TO THE CLAY COUNTY JAIL.

ON 01 MARCH 2008 AT 227AM THIS OFFICER WAS STOPPED BY A MOTORIST IN THE 300 BLK. PARK AVE. HE STATED HE WAS FOLLOWING A VEHICLE IN JACKSONVILLE THAT APPEARED TO BE DRIVING UNDER THE INFLUENCE. THE MOTORIST STATED HE CONTACTED F.H.P. AND ADVISED THEM OF THE VEHICLE DESCRIPTION AND DIRECTION OF TRAVEL. THE MOTORIST STATED THE VEHICLE STOPPED AT HWY 17 AND COLLINS RD. AND LET TWO BLACK MALES OUT OF THE VEHICLE. THE PICKUP THEN CONTINUED SOUTH BOUND AND WAS OBSERVED TURNING ONTO ELDRIDGE AVE. THIS OFFICER OBSERVED TWO BLACK MALES WALKING INTO THE PARKING LOT OF 206 PARK AVE. THE BLACK MALES GOT INTO A VEHICLE THAT WAS PARKED AT THE GAS PUMPS. I CONTACTED THE CLERK AND SHE TOLD ME THAT THE OCCUPANTS HAD STOPPED AT THE STORE TWO DIFFERENT TIMES DURING HER SHIFT. I OBSERVED THE VEHICLE LEAVING THE PARKING LOT AND IT CROSSED THREE LANES OF TRAFFIC. THE PICKUP HEADED SOUTH BOUND AND TURNED INTO THE TURN LANE OF PARK AVE AND WELLS RD. THE TURN ARROW TURNED GREEN AND THE PICKUP PULLED OUT OF THE TURN LANE WITHOUT SIGNALING AND PULLED INTO THE TURN LANE IN THE 400 BLK PARK AVE. I ACTIVATED MY BLUE LIGHTS AND THE PICKUP PULLED INTO THE ORANGE PARK KENNEL CLUB PARKING LOT. I MADE CONTACT ON THE PASSENGER'S SIDE OF THE PICK UP AND WHEN THE DRIVER OF THE VEHICLE WAS ASKED FOR A REGISTRATION HE OPENED HIS GLOVE COMPARTMENT. THIS OFFICER OBSERVED A HANDGUN IN THE GLOVE COMPARTMENT. A1 REACHED INTO THE GLOVE COMPARTMENT AND I INSTRUCTED HIM SEVERAL TIMES TO TAKE HIS HAND OUT OF THE GLOVE COMPARTMENT AND AWAY FROM THE HANDGUN. THE OCCUPANTS OF THE PICK UP WAS REMOVED I OBSERVED A PLASTIC BAG CONTAINING A WHITE POWDER SUBSTANCE ON THE PASSENGER'S SIDE FLOORBOARD. BOTH THE DRIVER AND PASSENGER DENIED KNOWLEDGE OF THE WHITE POWDER. THE WHITE POWDER WAS FIELD TESTED AND FOUND TO BE POSITIVE FOR COCAINE. A1 AND A2 WERE BOTH ARRESTED FOR POSSESSION OF A CONTROLLED SUBSTANCE AND BOOKED INTO THE CLAY COUNTY JAIL THE HANDGUN WAS CHECKED THROUGH NCIC/EJCIC AND PLACED INTO THE PROPERTY ROOM FOR SAFEKEEPING. THE VEHICLE WAS TOWED BY HORTON'S TOWING.
