## AFFIDAVIT of PROBABLE CAUSE

On 5/10/09 at appx. 2:30PM, the victim Ceaira Savage-Vadell (10 YOA) was standing in the area of 543 S. Duke St. with an unnamed juvenile witness and several others. The witness stated that there was a group of Black males (ages 14-21) from that area (South Side) standing a little further south of the victim and witness. One of the guys in the local group yelled "run" and the witness looked north of their location and observed a newer red 4-dr. vehicle that appeared to be a rental car, pull over a couple houses north of their location on the same side of the street. The witness described a Black male who exited the driver's seat, holding a black handgun, as 18-20 YOA, 5'10"-6', thin build, light to medium complexion. The suspect looked her way and held the gun sideways. Before running for cover, the witness glanced over and observed another Black male in the front passenger seat of the same vehicle. The witness grabbed a younger male and got behind nearby cover as appx. 4 shots were fired in their direction. Following the shots the suspect got back in the driver's seat and drove off, north on Duke, at a normal speed. The witness found the victim lying on the sidewalk nearby, bleeding from her side and mouth. A parked vehicle had also been shot. The victim was transported to York Hospital by private vehicle for treatment of a gunshot wound to the back. She was pronounced dead at the hospital due to those injuries.

Following the shooting, Douglas Orr was interviewed and stated that at the time of the shooting he was in the area of Maple & Duke St. and observed an unknown male throw a rock at the suspect vehicle as it drove by after the shooting, breaking off the passenger side view mirror. The mirror was recovered at the scene. The front passenger was also observed seated inside the passing vehicle, with a gun. The suspect vehicle was later found at 4:08PM by PO Hansel abandoned in the area of Fairmont Ave., to the rear of 227 Front St. There was damage to the front pass. door and the mirror was broken off. The vehicle was a red 2008 Dodge Avenger, 4-dr., bearing PA Reg. # GZV-3348. The vehicle was a rental from Penrac Inc.

At appx. 5:45PM, we spoke to [redacted], who rented the above suspect vehicle. [redacted] stated that in exchange for drugs, he rented the above vehicle to a Black male he knows as "G". A photo line-up was shown to [redacted] and he was asked to identify "G" and he pointed to the photo of the def. Nigel Maitland. Maitland is from the Parkway Projects area.


At 7PM, I showed photo line-ups to the unnamed juvenile witness and she identified the photo of Nigel Maitland as the male who exited the driver's seat with the gun at the time of the shooting.

We also received information about prior incidents involving a "beef" or feud between guys from the "South Side" and guys from Parkway Projects. On 5/10/09 at about 1:30AM, there was an unreported fight/assault between members of these two groups inside [redacted] Bar, where a member of the Parkway crew got beat up by members of South Side.

5/11/09, I also found out from Juvenile Probation that on 10/29/02 the def. Nigel Maitland was found guilty of Robbery in Juvenile Court and on 7/21/08 he was found guilty of 2 Cts. of Possession w/Intent to Deliver Controlled Substance, also in Juvenile Court.

Based on the above information, I am charging the def. with Criminal Homicide, Conspiracy to Commit Homicide and Persons not to Possess, Use, Manufacture, Control, Sell or Transfer Firearms.



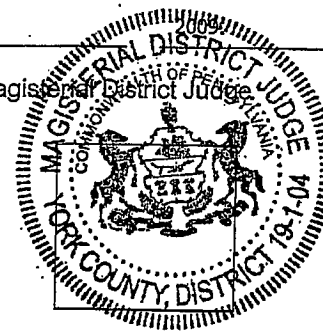
